- Each company may enter one man and one woman in the Archery competition.
- **No late check-ins will be allowed! Game Time is Forfeit Time!**
- Equipment that can be used - Compound (Bowhunter/fixed pin, Basic/Genesis or Competitive Freestyle/Open Compound), Recurve (barebow, traditional, Olympic Recurve or Longbow)
All archers will compete at 20 yards (60 feet) on an NFAA 5 spot target face or an NFAA 40cm single spot.
- **NO CROSS BOWS ALLOWED!**
- To begin tournament shooting, two (2) whistles indicating that it is okay to proceed to the shooting line will sound. Ten (10) seconds after arriving to the shooting line, one (1) whistle will sound, indicating it is now okay to shoot your five (5) arrows. Once all archers have completed shooting their arrows for the round, they will wait until three (3) whistles sound, indicating it is now clear to proceed to the target line to score and retrieve arrows.

- **DISQUALIFICATION** - If an arrow is shot before the one (1) whistle indicating it is okay to begin shooting, the highest scoring arrow will be disqualified, and one (1) additional point will be deducted from the score for that archer. The same thing will happen if an arrow is shot after the time for that round (4 minutes) has concluded and/or three (3) whistles have sounded. The archer will receive a warning. If this behavior of shooting before or after the correct indicators continues, the archer will be asked to leave and will be disqualified from the tournament.
- This will be a 5-Spot/40cm single spot tournament with 5 arrows shot each round for 4 rounds, totaling 20 arrows with a potential score of 100 points. Archers can choose to shoot between a single-spot or five-spot target face. Xs are counted as 5 points and used as tiebreaker.
 - Single Spot target face measures 40 centimeters in diameter. It has a white five-ring (X-ring in the very middle) and blue rings scoring 4, 3, 2, or 1 points.
 - Each of the five spot targets has a 5-ring, colored white, and an X-ring in the middle. Each spot has 2 blue rings, both scoring 4 points. Archers can shoot at the five spots in any order each end and shoot as many arrows into any spot they like. Cannot shoot more than 5 arrows each end.
 - Target choice needs to be made before first scoring end and continue to use the same target face throughout the tournament.
- Each round of 5 arrows is allowed up to 240 seconds or 4 minutes to shoot their 5 arrows.
- The X and white ring will equate to 5 points each. The blue rings in succession out from the white ring are both equal to 4 points. If the arrow lands in the target in a way that makes it touch the line, the score is given for the higher value. Any arrows shot outside of the 4 ring will be counted as a miss (M) for zero (0) points
- Sight lights will be permitted, however, no lighted nocks or electronic devices (phones, watches, earbuds, etc.) are allowed to be in use on the shooting line. No earbuds allowed in ears while archer is competing.
- The maximum arrow shaft diameter allowed is 0.42 inches with a point diameter no larger than 0.425 inches. Shaft diameter includes any wrap placed on the arrow and will include the nock and nock insert.
- Archers will be assigned a target space on their bale A/B on top, C/D on bottom. If archers would like to switch their assigned spot, they will need to coordinate with their bale mates, otherwise originally assigned spaces will be required. Once official practice begins, archer's targets will remain in the same place throughout the tournament.
- The archer must straddle the shooting line while shooting the required arrows.
 - A disabled archer shooting from a chair or wheelchair will place the chair legs or wheels straddling the shooting line.
- No archer may advance to the target until all arrows have been shot by all competitors and 3 whistles indicating it is okay to proceed to the target have sounded.
 - Disabled archers can assign, or have assigned to them, an advocate to go in their place to the target to contend their scores and pull arrows.
- Any arrow striking the wrong target shall be considered a miss and may not be re-shot.
- In the case of equipment failure, archer will need to step away from the shooting line and let a line judge know. Archer will be given 15 minutes for repairs. If repairs cannot be completed in 15 minutes, the archer forfeits their remaining rounds. One practice round may be shot when coming

back from equipment failure and then additional makeup arrows will be made up at the end of the official scoring rounds.

- If/when an arrow passes the 3 meter foul line, it is considered a shot arrow. If any part of the intact arrow remains on or behind the 3 meter foul line, the archer may shoot an additional arrow to make up for that miss-shot arrow. If the archer has no additional arrows to make up for the miss-shot/miss-fired arrow(s), they will need to wait until all arrows have been shot to retrieve that arrow. The archer will do a makeup shot at the end of the official scoring rounds.
- When shooting at target bales with multiple target faces, the first 2 shooters will be given the opportunity to shoot the bottom target faces during their 4 minutes first and then the additional archers shooting the top targets will proceed during their 4 minutes.
- There will be one caller (archer on each bale calling out scores for all bale mates), one written scorer (archer on each bale writing scores on paper scorecards for all bale mates) and one electronic scorer (archer on each bale using their personal device/phone to apply scores to live scoring software).
- When the tournament is completed, archers need to double check their score matches the live (electronic/online) scoring. Before turning in their scorecard, they will need to have signed their score card in the Archers Signature area and have 2 scorer signatures in the scorer signature areas of the score card. If the archer is also the electronic or written scorer, the caller will sign as one of the scorers.
- Report any unsafe conditions **IMMEDIATELY!**
- If there is a tie, the tie breaker will be determined by the total number of X's hit.
- Judges will be used to determine hits and misses. Confirm with the judge for any clarification on rules or points.
- **Participants must provide their own equipment.**
- **PRACTICE OPPORTUNITIES** - Contact Archery Excellence at 816-886-6281 for operational days/hours. KCCC Participants can go and practice from April 1st – April 20th for a discounted rate of \$10/hr per lane.
